CONSENT AGENDA – Motion J. Kelly, second Gustafson to approve the consent agenda item 3 (minutes of July 16 Council meeting and June Treasurer's report) THE MOTION CARRIED

PETITIONS, REQUESTS, & COMMUNICATIONS

TOURISM ASSOCIATION – George Pope and Council member Pat Kelley spoke in support of the request from the Silver Bay Area Tourism Association asking the Council to consider passing a city wide lodging tax in the amount of three percent. Council member Marolt stated the Economic Development Authority also supported passage of the lodging tax. Member J. Kelly noted the letter of request was neither dated nor signed and stated he felt it was a poor practice for Council to accept this type of communication. Member P. Kelley apologized for the oversight.

Chuck Potter, representing the owners of the AmericInn, said the owners had originally favored a lodging tax when they thought there would be more businesses involved, but now that it appeared their facility would be accounting for 80% or more of the money generated, the group no longer supported the tax. Andy Fisher and Council member P. Kelley talked about the benefits of promoting the community and the area as a whole in order to bring more tourists into the city and the area, which would benefit individual businesses. George Pope stated funds generated by the tax would be used for such things as a web site and a brochure to market the area to the nation. No decision on the tax was made by Council. NEXT AGENDA

CITY ADMINISTRATOR – REQUEST TO SET FY08 BUDGET WORK SESSIONS – Council set Wednesday, August 15, at 8:30 a.m. as a budget work session.

REQUEST TO EXTEND AIRPORT MANAGER'S CONTRACT – Changes are being made in the job description for the airport manager. Mr. Smith asked for approval to extend the current manager's contract, which expired July 31, for 60 days.

Motion J. Kelly, second Gustafson to extend the contract of the current airport manager, which expired July 31, by 60 days. THE MOTION CARRIED

CITY ATTORNEY – NUISANCE ENFORCEMENT – City Atty. Johnson said he, the Asst. City Atty., and members of the police department had inspected properties within the city and reviewed the various complaints that had been submitted to the police department. Three of the items warranted prosecution, Atty. Johnson said. He explained the process of warning letters and citations that would be utilized. Audience member Jack Swanson complained that the police were not enforcing the city ordinances.

Atty. Johnson referenced his July 24, 2007, letter of opinion regarding a donation to a group for purposes of promoting tourism. The opinion states the council can not expend public funds as requested by the Silver Bay Area Tourism Association.

JOINT POWERS AGREEMENT--NORTH SHORE DRUG RESPONSE TEAM – Atty. Johnson noted the Joint Powers Agreement had been revised according to the requests of the Council and therefore now met the City's requirements.
