Petitions, Requests and Communications

Ground Breaking Ceremony – It was noted that there will be a ground breaking ceremony for the Beaver Bay trailhead on August 5. It has been posted that a quorum of the Council will attend.

Informational Meeting – It was noted that the County Highway department will have an informational meeting in Beaver Bay on August 7 about the Beaver Bay trailhead project, County Road 4 project, and paving County Road 5 in the City (Outer Drive and Penn Ave).

Oath of Office, Presentation of Badge – Mayor Johnson administered the oath of office for police officer to Robert Hakala, and presented him with his badge.

Oath of Office, Presentation of Badge – Mayor Johnson administered the oath of office for police chief to Douglas Frericks, and presented him with his badge. Frericks thanked the Council, his family, the officers of the department, the Lake County Sheriff's department, and stated it is an honor to serve the residents of Silver Bay.

Public Utilities Commission Appointment – The Council reviewed an application from Gary Stevens to this Commission. Motion by Perfetto, second Goutermont to appoint Gary Stevens to the Public Utilities Commission. MOTION CARRIED.

MN DOT Airport Maintenance and Operation Agreement Amendment — It was noted that the MN DOT has received a one-time allotment to increase the state's share of airport maintenance costs 2014, that the 2014 allotment will be \$15,132.70, and will return to \$13,757 in 2015. There was discussion about the airport maintenance costs. Motion by Perfetto, second Goutermont to approve the amendment to the MnDOT Grant Agreement #03936. MOTION CARRIED.

Water Emergency Backup Project, Geotechnical Exploration Proposal – The Council reviewed two proposals for geotechnical exploration for this project. It was noted that American Engineering and Testing is the lowest proposal, and is recommended by the Utilities Superintendent and Mike Miller Engineering. Motion by Goutermont, second Perfetto to approve the proposal for Geotechnical Exploration and Report from American Engineering and Testing Inc., for \$3,875. MOTION CARRIED.

City Attorney – No other business was presented by the attorney.

NEW BUSINESS – No new business was presented.
