## **City Administrator**

Chief of Police Position — It was noted that Mitch Dow has been serving as acting chief for six months and that this time will be credited towards his one year probation period upon his appointment to Chief of Police. He will remain at 95% of pay scale until his one-year probation period has been completed which would be September 20, 2012. Motion by Perfetto, second Marolt to appoint Mitch Dow as the Chief of Police, effective April 3, 2012. MOTION CARRIED. Mayor Johnson administered the oath of office to Dow, and the Council congratulated him on this appointment.

**Resolution 2011-25** — The Council reviewed this contract and the bid process. The Public Utilities Commission recommends awarding this contract Magney Construction Inc. as the lowest responsible bidder with a bid amount of \$112,750.
