CITY ADMINISTRATOR

Fit City / NE SHIP Grant Award – The City has been awarded a \$5,000 Fit City Grant which will be used to purchase 50 bike helmets for a bike rodeo, 8 bike racks and 3 Fit City signs. The Council reviewed the agreement for this grant. Motion by Perfetto, second Gustafson to authorize the Administrator to sign the Fit City Grant agreement. <u>MOTION CARRIED.</u>

Budget Workshop Meetings – Motion by J Johnson, second Perfetto to hold City Budget Workshops on Monday, August 2, and Monday, August 16, at 5:00p.m. <u>MOTION CARRIED.</u>

ReUnion Hall Rental Fees – The Liquor Control Commission has recommend to set a three tiered rental fee for the ReUnion Hall of \$50 for benefits (plus cleaning costs), \$250 for non-alcohol events (plus cleaning costs), and \$500 for alcohol events. Cleaning costs were discussed. There was also discussion that some alcohol events do not require a Police officer, and the \$150 cost for this service. There was discussion on having a four tiered fee schedule of \$50 for benefits (plus cleaning costs), \$250 for non-alcohol events (plus cleaning costs), \$350 for alcohol events not requiring Police service, and \$500 for alcohol events requiring Police service. It was noted that Resolution 2010-5 would need to be amended to accommodate this fee change. Motion by J Johnson, second Perfetto to approve a four tiered fee schedule for the rental of the ReUnion Hall. <u>MOTION CARRIED</u>.

CITY ATTORNEY – No further business was presented by the attorney.

OLD BUSINESS – No other old business was presented.

NEW BUSINESS

Claims – Motion by Perfetto, second Gustafson to approve payment of \$92,917.37 paid claims and \$59,035.11 in unpaid claims. <u>MOTION CARRIED.</u>
