Agenda – Correspondence regarding Cliffs Natural Resources was added to communications. Motion by Perfetto, second Marolt to approve the agenda as amended. <u>MOTION CARRIED</u>.

Consent Agenda – Motion by Gustafson, second Goutermont to approve the minutes of the April 15, 2013 Council meeting. <u>MOTION CARRIED</u>.

Petitions, Requests and Communications

Correspondence regarding Cliffs Natural Resources – Mayor Johnson reported on letters that she has written to MN Pollution Control, Senator Bakk and Rep. Dill regarding an ongoing health study of mine workers, and how it affects Cliffs Natural Resources.

City Administrator

Summer Part-time Employment – The Council reviewed a list of employees to fill the seasonal employment positions that is recommended by the Personnel Committee. The City will begin hiring these employees as early as May 7, with the date of hire for each individual to be determined by the department heads. Motion by Perfetto, second Marolt to approve the seasonal employment hiring list at wages indicated. <u>MOTION CARRIED</u>.

Liquor Store Manager Training – The Council reviewed information about this training and there was discussion about whether or not attendance was needed on the last day of the conference. Motion by Perfetto, second Goutermont to approve for Tom Byrnes to attend the MMBA conference in Alexandria on May 19-21, for \$489, which includes three nights lodging and six meals, plus regular mileage and meals. Goutermont, Perfetto, Marolt and Johnson voted aye, Gustafson voted nay. <u>MOTION CARRIED</u>.

Resolution 2013-19 – Agreement with LHB Engineers for Golf Course Bridge – It was noted that the Council approved to enter into this agreement at the April 1 meeting, that the attorney has reviewed this agreement, that if hydrology testing is needed the agreement will need to be amended, and that funding will come from an insurance claim.

Motion by Perfetto, second Gustafson to adopt Resolution 2013-19 authorizing to execute an agreement for professional services from LHB Inc. for engineering services in connection with the golf course bridge.

Resolution 2013-20 – Agreement with Contech Engineered Solutions for Golf Course

Bridge – The Council reviewed two quotes for manufacturing and delivery of a bridge for the golf course, and it was noted that both guotes were reviewed by LHB and met the specifications of the project, and that Contech Engineers had the lowest bid. Motion by Marolt, second Goutermont to adopt Resolution 2013-20 authorizing to accept the proposal from Contech Engineered Solutions, LLC for the design, delivery and warranty of a 70'x12' bridge to be delivered to the golf course, for \$47,433.
